

## Terms Of Use

### 1. Background

- 1.1. factohr.com and \*.factotime.com (“Websites”) and the mobile apps, web interfaces, APIs, documentation, servers and all other Intellectual Property, software and infrastructure (individually referred to as “factohr Application” and collective as “factohr ” are owned, registered and operated by version system Pvt Limited ("Company"), a company, incorporated in India.
- 1.2. These Terms of Use (“Terms of Use”), which include and hereby incorporate the Privacy Policy at [factohr.com] (“Privacy Policy”), are a legal agreement between the Company and you (“You ” or “User”). By using or accessing factohr, you agree (i) that you are 18 years of age or older, (ii) if you are the age of majority in your jurisdiction or over, that you have read, understood, and accept to be bound by the Terms of Service and the Privacy Policy.
- 1.3. We reserve the right to make changes to these “Terms of Use” at any time. Any such modifications will become effective immediately upon posting to the Website/factohr Product and your continued usage of the Website/factohr Product, and/or the Services (as defined below) constitutes your agreement to such modifications. You agree to periodically review the current version of these Terms of Use as posted on the Website/factohr Product.

### 2. Services and Restrictions on Usage:

- 2.1. You may use the Services in accordance with our contractual arrangement with you or your Employer / organisation that you represent.
- 2.2. Subject to your compliance with these Terms of Use, the Company grants you a limited, revocable, non-exclusive, non-transferable, non-sublicensable license to use and access the Service.

- 2.4. Company reserves the right to modify or discontinue, temporarily or permanently, the Service (or any part thereof) with or without notice. - 2.5. If you violate these Terms of Use, the Company reserves the right to issue you a warning regarding the violation or immediately terminate or suspend any or all accounts you have created using the Service. The courts in Hyderabad, India, shall have the exclusive jurisdiction to determine any disputes arising in relation to, or under, these Terms of Use.
